Animal Intake and Instruction

Office hours are 8:00am to 6pm you may drop off during these hours. **CHECK OUT TIME IS 12 NOON** if your pet is not picked up by 12 noon you will be charged \$10 for pickup before closing at 6pm. **Gate is locked from 1pm-2pm.**

All pets must have a Veterinary and vaccination record at the time of check in.

Full payment is due at the time of check out. For long term stays over 14 days a deposit is required and weekly payments must be made. And a valid credit card must be on file with consent to charge your account for payments.

Douglas County Pet Lodge is not held responsible for any Veterinary visits, emergency or otherwise, disease or sickness contracted during the stay, injuries by or to your pet, damage to their personal property from chewing or urine.

Any animal left for **72 HOURS** past the scheduled check out with **NO CONTACT** from the owner will be considered abandoned and will be taken to: Saving Grace Pet Adoption Center at 450 Old Del Rio Rd, Roseburg OR, 97471. Your total bill plus \$1,500 and lawyer fees will be taken to collections.

Dog Boarding and Daycare Health Disclosure and Release of Liability

THIS AGREEMENT is entered into by and between Douglas County Pet Lodge (DCPL) and the dog owner (NAME), _____ ,

Dog(s) name and breed(s), _____

I (Owner) acknowledge that I am the legal owner of the above-named dog and I assume all risks, dangers, and responsibility for injuries. Owner understands and agrees that Owner is solely responsible for any harm that may impact dog(s) while attending Daycare or Boarding.

1. **GENERAL HEALTH:** Owner agrees that dog(s) are healthy while attending DCPL will always maintain current vaccinations for Rabies, Distemper, Parvo and Bordetella. Owner is not enrolling any dog that has any communicable condition that could jeopardize the health of other dogs or people within 30 days prior to visit. Owner understands that even if a dog is vaccinated for Bordetella (Kennel Cough) there is a chance that a dog can still contract Kennel Cough. Owner agrees that Owner will not hold DCPL responsible if a dog(s) contracts any dog-transmitted ailments.
2. **GROUP PLAY:** DCPL may accept or decline any dog it deems to not be a good fit for group play. Owner agrees that dog's enrollment in group play is group play, not individual health. Any dog demonstrating aggression or other behavior deemed unacceptable by DCPL staff may be required to leave group play. Other arrangements for the exercise and play area for dog(s) will be provided.
3. **FOOD/MEDS:** When boarding overnight, Owner agrees that it is their responsibility to leave an adequate supply of food and medications for a dog(s) that is the precise time a dog(s) needs their dosage. Should DCPL staff need to replenish any food, boarder, Owner authorizes DCPL to feed dog(s) food and any replacement food will reimburse DCPL for food and time purchasing food for \$20.00 time/distance trip plus the cost of food.
4. **VETERINARIAN LIABILITY AND CARE:** Owner Agrees to allow DCPL to obtain medical treatment for dog(s) if they appear ill, injured, or exhibit any unusual behavior and will hold reasonable fees by DCPL of dog(s). DCPL will make reasonable efforts to contact Owner prior to obtaining emergency treatment. Owner agrees to be responsible for any transportation for the purposes of such treatment.

Owner gives permission to DCPL to use Owner's vet, vet nearest to DCPL or 24-hour vet hospital for required treatment.

5. **WEAKENED IMMUNE SYSTEM:** Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding the Owner is waiving any claim for injury or illness experienced by Owner's dog while in our care. Owners of elderly dogs (any dog past middle age) naturally have a higher risk of injury or death. In the unlikely event Owner's dog passes on while in our care, Owners dog will be transported to their Veterinary Clinic. Our policy is only to hold deceased dogs for no more than 24-hour. Transportation can be provided at Owners expense. Trip charges will be based on time/distance.

6. **RIGHT OF REFUSAL:** DCPL reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament, or other daycare/boarding standards. The determination shall be made at the sole discretion of DCPL.

7. **RELEASE OF LIABILITY:** Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by DCPL staff to best avoid injury, scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. DCPL employees, staff, or volunteers will not be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases DCPL of any liability of any Owner's dog(s) attend DCPL. Owner has been made aware of Oregon dog bite law, Section 31.360 of the Civil Code, states that the owner of any dog is liable for damages if: the damages were caused by a dog bite, and the person or dog was bitten was in a public place or lawfully in a private place.

8. **FULL FORCE AND EFFECT:** Owner further understands and expressly agrees that sections providing full force and effect in paragraphs 1-8 shall be in force and effect and shall apply to every dog attending which Owner's dog(s) stays with DCPL for daycare, extended stay, and all other arrangements. This Agreement shall remain valid and in force as long as Owner's dog(s) attend or are cared for by DCPL for any reason. Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
